1. Publication Working Group

 The CP-CTNet Publication Guidelines were approved and will be emailed to CP-CTNet colleagues and will be posted to the CP-CTNet DMACC website under Resources - https://www.cp-ctnet-dmacc.org/public/program-resources/.

2. EDI Committee Update

- Subcommittees
 - EDI for Education
 - The committee plans on sending out a learning-needs survey to all the LAOs to be passed through to the AOs as well.
 - EDI in Clinical Trials
 - The committee is discussing best practices, improving the protocol template to address inclusion, how to improve recruitment strategies and will be directly addressing exclusion/inclusion criteria.
 - EDI in Staffing
 - Dr. Howard Bailey is polling CP-CTNet sites regarding EDI institutional policies and staffing.

3. Cross-Network Trial Update

 The trial INT21-05-01 received Approved on Hold status on 02.23.2022 and is awaiting FDA response on the IND. We should hear by 04.24.2022. The following are still pending: regulatory documents, SVAR approval, agent availability and study initiation visit.

4. Changes in Study Pls

- Reminder to LAOs to share all staffing changes with PIO, DMACC, and CP-CTNet leadership. An SOP is being developed to give guidance on this procedure.
- 5. LAO Oversight/Monitoring vs. DMACC Auditing





Discussions continue amongst CP-CTNet leadership, LAOs and DMACC.
 DMACC will develop tools to help LAOs with monitoring to include providing reports to the LAOs. SOP 03-03 LAO Oversight of AOs is in the process of being revised with input from DCP, DMACC and LAOs.

6. International Site GDPR Issues

GDPR = General Data Protection Regulation - it is a privacy and security law
in the European Union (EU) that is similar to HIPAA in the US. Though it was
drafted and passed by the EU, it imposes obligations onto organizations
anywhere, so long as they target or collect data related to people in the EU.
The regulation was put into effect on May 25, 2018. This has implications on
CP-CTNet trials that will include European sites. CP-CTNet may need to look
into separate monitoring/auditing teams in Europe to cover trials conducted
there.
