## 1. I-SCORE 2023

- Dates for the next I-SCORE meeting were confirmed for 3/30/23-3/31/23 and a Save the Date calendar invite was sent. The meeting will be a hybrid format (in-person in Rockville, MD and virtual).

## 2. Participant Advisory Board

- Dr. Sahasrabudhe, with Maggie House, Ellen Richmond, and Dr. Szabo provided an overview of internal DCP discussions to form a Participant Advisory Board (PAB) for CP-CTNet, and sought input from the Steering Committee. DCP will continue further planning and will reach out to CP-CTNet grantees for further discussion on this topic.

## 3. EDI Committee Update

- Subcommittees
  - EDI for Education
    - CP-CTNet Equity, Diversity, and Inclusion Webinar will be presented on 8/2/2022.
  - EDI in Clinical Trials
    - Inclusion/Exclusion criteria were modified on the protocol templates for all CP-CTNet trials.

## 4. Cross-Network Trial Updates

- INT21-05-01 Tri-Ad5/N-803 Vaccine for Lynch Syndrome
  - The SVAR is being worked on. The goal was to have this trial open for accrual by 8/1/2022 but it likely will open in mid-September.
- INT22-09-01 Randomized Trial of Apalutamide in Non-Muscle Invasive Bladder Cancer
  - Dr. Bailey formally presented this study to the Steering Committee, and it was approved.

## 5. Data and Safety Monitoring Board (DSMB)

- Dr. Szabo reached out to 5 individuals and all accepted the invitation to serve on the DSMB for the CP-CTNet cross-network trials. A meeting will be convened in the fall before the first participant goes on the INT21-05-01 trial.

## 6. Working Group for Cross-Network Trials

- A working group will be formed to better define the cross-network trial process and will include members from DCP, DMACC, and the LAOs.

## 7. SOP03-03 LAO Oversight Activities

- SOP03-03 was finalized with input from DCP, DMACC and LAOs.

## 8. International Site GDPR Issues

- A resolution was reached for CP-CTNet trials with European sites.
