## 1. NCI Update

- DCP is working on resolving the carryover concerns.
- ODS (NCI Office of Data Sharing) plans to implement the 2023 Data Management and Sharing (DMS) Policy soon; which will replace the 2003 Data Sharing Policy. [Your Guide to the 2023 NIH Data Management and Sharing Policy | CBIIT \(cancer.gov\)](#)

## 2. DMACC Update

- DMACC is piloting a proof-of-concept with MDA for an official, centrally-managed REDCap data collection instrument, which is to be built, maintained, and validated by DMACC and made available to LAOs to integrate with and/or leverage an LAO's existing REDCap infrastructure.
- The Virtual Specimen Repository website and related visualization is updated and is expected to be piloted by the end of April 2023. (e.g., revised text content, added support for more trials and specimen types, and adjustment to default filters on the visualization).
- The DMACC is working with Ellen Richmond (NCI/DCP) to develop a report to reflect AQUIP-type data regarding trial stage and accrual barriers broken down by demographics (e.g., age, sex, race, etc.).
- The DMACC is leveraging an existing Frontier Science utility for visit forecasting for CP-CTNet purposes, which is to be made available to DMACC Data Managers in May 2023.

## 3. CP-CTNet Committee Updates

- EDI Committee Update
  - EDI subcommittee for Education
    - The Education Webinar is May 19, 2023. A panel of experts will discuss strategies to improve minority enrollment into clinical trials.

- **EDI subcommittee for Staffing**
  - No update.
- **EDI subcommittee for Clinical Trials**
  - There are discussions around incorporating patient advocates/navigators into the next iteration of the CP-CTNet program.
- **Cross-network Trial Working Group**
  - The working group has provided great feedback for helping revise the current guidelines. Work is in progress.

#### 4. Cross-Network Trial Updates

- **INT21-05-21 Tri-Ad5/N-803 Vaccine for Lynch Syndrome**
  - This trial has been activated and soon will start enrolling participants.
- **INT22-09-01 Randomized Trial of Apalutamide in Non-Muscle Invasive Bladder Cancer**
  - In progress. Dr. Edward Messing presented on this trial during the I-SCORE 2023 meeting.
- There is a proposed new Cross-network trial for CP-CTNet. Stay tuned.
