1. NCI Update

3. DMACC Update

- **ePRO**
 - **DMACC is piloting a proof-of-concept with several LAOs for an official, centrally-managed REDCap data collection instrument, which is to be built, validated, and maintained by DMACC and made available to LAOs to integrate with and/or leverage an LAOs existing REDCap infrastructure. Ms. Siminski is researching options to include ePRO modules in Medidata Rave and MyCap. Dr. Chow mentioned looking into the Visiontree app. Dr. Heckman-Stoddard will inquire what the other groups within NCI are using for ePRO collection.**
- **Virtual Specimen Repository (VSR)**
 - **Over 3,600 LDMS specimen records across seven studies to date have been received. Dr. Khan requested a denominator be shared in the future.**
 - **The VSR visualization was made available recently to staff in the Portal Gateway.**
 - **A lengthy discussion was had by all SC members with regard to remaining samples and the possibility of being able to track those samples using the LDMS.**

5. Cross-Network Trial Updates

- **INT21-05-01 Tri-Ad5 and N-803 Vaccines for Lynch Syndrome**
 - **The randomized phase of this trial was recently opened. Three participants have been randomized and are currently on study.**
 - **Immunogenicity data has been challenging due to irregularities in shipping/specimen processing.**
- **INT22-09-01 Randomized Trial of Apalutamide in Non-Muscle Invasive Bladder Cancer**
 - **The CTA should be approved soon and the trial will be activated in the near future.**

- **INT23-14-01 Refining Tamoxifen Dose for Premenopausal Breast Cancer Prevention (RENAISSANCE): A Phase II Single Arm Trial**
 - The trial was expected to open 4/30/24 but has been pushed to 7/17/24 due to drug availability issues with MRI Global.

6. New Topics

- **Cross-network MTA issues**
 - Dr. Brenner reported that this topic still continues to be challenging and there doesn't seem to be any movement toward a single use MTA.
- **Dr. Heckman-Stoddard indicated that Re-Entry/Diversity Supplements are available during the Open Cycle of February 1-March 31.**
